- Lift Station Upgrades Upgrades are needed to PS # 6, #11 and 13 to accommodate anticipated future build out and enhance system operations. Ruekert Mielke is doing a study to determine what alternatives we have for Station 6, 11 and 13 to accommodate the existing and the future flows.
